Tents/pavilions are not provided. Booths are indoors, so tents/pavilions are not required, although footed tents/pavilions are encouraged to enhance ambiance. Clan booths are away from the Main Stage and decorations are strongly encouraged to attract visitors to your booth.

Please don't litter. Any trash you have is your responsibility to clean up before you leave! Trash cans will be provided around the area for visitor's usage.

Clan tent breakdown and removal will be after the final concert on Sunday. This will be at 6:00pm. No vehicles will be allowed in the Pavilion prior to 6:00pm for everyone's safety!
